**CIRCULAR**

**Attention: Students admitted during 2015, 2017 & 2018, Regulations.**

**Sub: Special provision to appear for Summer Semester**

Special One-Time Provision only for students admitted under 2015, 2017 & 2018 regulations are as follows:

- a. Students having an 'F' Grade in any course, shall re-register for that course in the summer semester, obtain the attendance and CIE and appear for the SEE. The maximum permitted credits for re-registration during the summer semester **is limited to 16**.
- b. As a special provision
  - i. Students who have completed the courses up to the final semester (VIII semester B.E.) and are left with backlogs satisfying the minimum CIE marks, may be permitted to register directly to SEE for **any number of courses** during the summer semester, offered at the end of VIII semester.
  - ii. Students who have completed the courses up to the final semester (VIII semester B.E.) and are left with backlogs without satisfying the minimum CIE marks, may be permitted to re-register for **any number of courses**(the maximum number of courses are relaxed)during the summer semester, offered at the end of VIII semester and satisfy the attendance and CIE requirements to appear for SEE.
  - iii. This is subject to the permitted maximum duration of the B.E. programmes notified in the Regulations applicable to them and as per VTU notifications issued from time to time.

The students who are willing to register for the Summer Semester shall submit their application to the Office of CoE duly verified by the proctor and the Head of the Department. **The details of applicable fee, registration procedure will be notified by the Office of CoE. The Academic calendar for the Summer Semester will be announced shortly by the Office of Dean (Academic Affairs).**

Note: 1. The students shall also submit an undertaking with regard to any modifications in the Regulations/ Circular issued by VTU/ Institute from time to time.

**Subject:** Special Provision for students at Autonomous Colleges admitted under 2015, 2017 and 2018 VTU Regulations to appear for summer semester - reg...

#### Preamble:

A Few students admitted to the Autonomous colleges under 2015, 2017, and 2018 Regulations and completed all the 8/10 semesters (8<sup>th</sup> for B.E. and 10<sup>th</sup> for B.Arch.) have given representation to the concerned College Principals requesting them to appear for all backlog papers at a time. The College in turn forwarded the request to the University. The request was placed before the Autonomy Guidelines Committee (ref. 1 and ref.2), and on approval of the recommendations by the Hon'ble Vice Chancellor, the following is informed.

#### Special One-Time Provision for students at autonomous colleges admitted during 2015, 2017 and 2018:

- (a) For students admitted under 2015, 2017, and 2018 Regulations, a student having an 'F' grade in any course, shall re-register for that course in the summer semester, obtain the attendance and CCE (Continuous Comprehensive Evaluation), and appear for the SEE. The maximum permitted credit for re-registration during the summer semester is limited to 16.
- (b) As a special provision,
- Students who have completed the courses up to the final semester (8<sup>th</sup> for B.E. and 10<sup>th</sup> for B.Arch.) and are left with backlogs satisfying the minimum CCE marks, may be permitted to register directly to SEE for any number of courses during the summer semester, offered at the end of 8<sup>th</sup> semester.
  - Students who have completed the courses up to the final semester (8<sup>th</sup> for B.E. and 10<sup>th</sup> for B.Arch.) and are left with backlogs without satisfying the minimum CCE marks, may be permitted to re-register for any number of courses (i.e., the maximum number credits are relaxed) for

- iii. **This is subject to the permitted maximum duration of the programs as notified in the Regulations applicable to them and as per University notifications issued from time to time.**
